All required transfer fees are due at the time of application. \*Customer Service Reports and Backflow Test and Maintenance Reports are not required for residents of Windcliff Harbor

Before permanent service is granted to the new property owner, the service address must have a Customer Service Inspection (CSI) performed by a Texas State Licensed CSI Inspector. If the service location fails to pass the CSI, the service address must be brought into compliance with the current state laws and/or local District ordinances for service to continue. Additionally, all backflow devices required by the CSI must be inspected and certified by a Certified Backflow Assembly Tester to be in proper working order. Originals of CSI Reports and Backflow Assembly Test Reports must be on file at the district office.
